

British Columbia Miniature Horse Club Futurity Rules

ELIGIBILITY:

The owner of the foal must reside in Region 10 and must be a current BCMHC member. The nominated foal must reside in Region 10 and must be registered with AMHA prior to entering the Futurity Class at the Official Show.

OFFICIAL SHOW:

The BC Spring Classic show held in Chilliwack, B.C. or at such other location designated by the BCMHC will be the Official Show for the BCMHC Futurity.

FUTURITY FORMS AND FEE PAYMENTS:

Forms may be obtained by contacting the Futurity Chairperson or can be obtained on the BCMHC website at www.miniaturehorsesbc.com. Futurity payments should be make payable to BCMHC or British Columbia Miniature Horse Club and should be mailed along with the Futurity Forms to the Treasurer, BCMHC.

GENERAL:

To be eligible for Futurity honours and payouts, entrants must be current in their futurity nominations and payment of Futurity Fees and must be the registered owner of the AMHA registered horse. As soon as any fees on the Schedule become past due, that horse is no longer eligible for the Futurity and the owner forfeits any fees paid up to that date. No substitutions will be allowed under any circumstances. **For the 2018 year owners may pay any past due sustaining fees and then will be eligible to enter the 3/4 year old Driving Futurity or the 3/4 year old Hunter Futurity.**

FEE SCHEDULE:

All applications must contain a completed Futurity Form for each foal as well as the correct entry fees and must be received by the Treasurer or post marked on or before:

January 31 of year after breeding (in utero) **Nomination**..... \$10.00
 January 31 of year after foaling (weanling) **Sustaining** \$30.0
 January 31 of two year old year **Sustaining**\$30.00
 January 31 of the three and four year old years \$30.00

JUDGING:

All horses will be judged by the AMHA halter rules current as at the date of the Official Show. Judges scores will be totalled for each horse.

FUTURITY CLASSES:

Yearling Males
Yearling Fillies
Two Year Old Males
Two Year Old Fillies
3/4 Year Old Driving
3/4 Year Old Hunter

Entries in the Futurity Classes at the Official Show and payment for the Futurity Class fees must be received by the Show Secretary no later than **five (5) days prior** to the date of the Official Show. Late entries, post entries and substitutes are not allowed under any circumstances.

All horses entering the Futurity Class must also be shown in a regular **Open** class at the Official Show.

TRANSFER:

In the event that the foal is sold before the Futurity Class, Futurity eligibility is transferred to the new owner. The seller should provide the nomination and Futurity information to the new owner. The new owner must pay the fees when they come due to keep the foal eligible. They should also provide a copy of the AMHA papers noting the ownership transfer to the Futurity Chairperson. The new owner must be a BCMHC member and reside in Region 10.

FUNDS:

All funds paid into the Futurity and for the Futurity Classes, with the exception of the cost of awards and ribbons, will become prize money for the Futurity Classes.

RECORDS:

The Futurity Chairperson will maintain the records for the Futurity and the Treasurer will hold the funds.
